Finance and Economic Development

- a. Payables Presented for Council information only.
- b. Snow clearing invoices and logs for the period of January 1 to February 4, 2017 –

Be it resolved that Council pay the snow clearing contractor, Harbour Construction, for invoices for the period of January 1 to February 4, 2017. **Motion carried unanimously.**

c. Mobile Central High School – Senior's Outreach Dinner

d. Motion to accept budget cost overruns for Southside Track Phase 2 (\$24,375) – Geraldine informed Council that the Department of Municipal Affairs notified the Town Office that the cost of overrun must be paid, and a motion needs to be made to process the payment. The Department stated that Council had the option of applying for the extra funding to offset the cost of the overruns.
